Legal requirements:

- All companies with more than 250 employees must have established a whistleblowing system by the end of 2021 – smaller companies are granted slightly more time.
- The German legislator is currently transposing these requirements into directly binding German law.
- Companies that fail to implement the system on time will be subject to sanctions, including fines.







Compliance



Actual operation of the whistleblowing system

We assume the internal investigation and resolution of serious legal violations and support management in an advisory capacity.




Technical implementation with WhistleB

WhistleB offers a user-friendly whistleblowing system that meets the strictest security standards to protect you, your workforce, your data, and your organization's reputation. The reporting channel allows your employees and stakeholders to anonymously report suspected misconduct so that you can respond right away. Whistleblowers' reports are managed securely and efficiently as "cases" in the online case management tool.

How the system works

1. Reporting channel

The whistleblower reports an event of concern by accessing the reporting channel homepage and filling out the questionnaire. The web-based channel is accessible from all devices, including smartphones.



The whistleblower can send the notification anonymously or openly in any language.

2. Case management tool

The Case Manager receives immediate notification via email and text.



After logging into the case management tool, the Case Manager reviews and responds to the notification. Login is secure and includes multi-factor authentication. Support for secure translations is included.

3. Dialog between Case Manager and whistleblower

The dialog between the Case Manager and the anonymous whistleblower continues. Logging into the notification channel, the whistleblower reads the Case Manager's response. Data is encrypted during transmission and storage.




You decide the access to notifications by individuals in your organization, because only authorized case managers may decrypt and read notifications.

4. Investigations of notifications

Investigations of notifications are supported by advanced, user-friendly investigative functions.



These include, but are not limited to, notification categories, process status, notes, file uploads as evidence, and secure chat between authorized individuals or reassignment of the entire case.



Once an investigation is complete, the case is closed in accordance with applicable statutory provisions, such as the GDPR.

5. Assessment tools

Statistics and report generation tools provide an overview of current and historical data, status, notifications, performance metrics, and detailed analysis.



The dashboard allows you to individualize settings. The report generator offers flexible options, such as a standard presentation for specific target groups.
